 ACTIVE MEMBER - "Any member of the Florida Bar or authorized house counsel (as defined under Chapter 17 Florida Bar Rules) in good standing, actively engaged in the practice of law or actively employed as a lawyer in Duval, Baker, Clay, Nassau, or St. Johns County, Florida, shall be eligible to be an active member."

 ASSOCIATE MEMBER - "Any member of The Florida Bar in good standing or any member in good standing of the bar or similar body of another state, provided requirements for membership are found by the executive committee to be equivalent to requirements for admission to The Florida Bar, who either resides or is employed in Duval, Baker, Clay, Nassau or St. Johns County, Florida, and who is not actively engaged in the private practice of law in Duval, Baker, Clay, Nassau or St. Johns County, Florida, and who is not an honorary member by reason of being a judge, shall be eligible to become an associate member."

 NON RESIDENT - "Any active or associate member who moves from Duval, Baker, Clay, Nassau or St. Johns County, Florida, may become a non-resident member. Non-resident members may neither vote nor hold elective office in the Association but shall be entitled to all other privileges of membership."

 STUDENT MEMBER - "Any current student of a law school with either accreditation from the American Bar Association or provisional accreditation from the American Bar Association shall be eligible to become a Student member. Student members may neither vote nor hold elective office in this association, but shall be entitled to other privileges of membership as determined by the Board of Governors periodically."
